

***CATALYTIC CONVERTER LIMITED WARRANTY**

AirTek, Inc. d/b/a CATCO (“CATCO”) makes the following limited warranty to the original retail purchaser of this catalytic converter:

- 1. LIMITED WARRANTY** This catalytic converter is warranted to be free from defects in material and workmanship subject to the exclusion and conditions set forth below and subject to the durational limits in this paragraph. This catalytic converter has been designed and manufactured and is warranted to meet federal Environmental Protection Agency emission requirements for 25,000 miles. The stainless steel body and the nipple alone are warranted for 5 years or 50,000 miles, whichever comes first. At the conclusion of the 5 years/50,000 miles on stainless steel body and nipples or 25,000 mile period, whichever is applicable, all liability under this limited warranty shall terminate.
- 2. DEFECTS** If this catalytic converter is defective, AirTek will supply the purchaser with a new catalytic converter provided the following conditions are met:
 - a.** The purchaser must return the converter to an authorized dealer, along with the completed warranty claim card and proof of purchase;
 - b.** If the warranty claim relates to emission performance, the purchaser should provide proof of failure of an emissions test;
 - c.** AirTek, Inc. may require the purchaser to provide proof that the engine was tuned to original manufacturer’s specifications and maintained in proper operating condition.

THE OBLIGATION OF AIRTEK, INC. UNDER THIS WARRANTY IS TO SUPPLY THE PURCHASER WITH A NEW CATALYTIC CONVERTER. IN CALIFORNIA, THIS WARRANTY INCLUDES THE FULL REPLACEMENT COST, UP TO THE AMOUNT OF THE ORIGINAL PURCHASE, INCLUDING LABOR.

- 3. EXCLUSIONS** Failure or defects caused by the following are not covered by this warranty:
 - a.** Improper installation (including installation on a vehicle for which the converter has not been cataloged) or failure to maintain the vehicle in proper operating condition with all emissions control equipment properly connected and operating according to vehicle manufacturer’s specifications;
 - b.** The use of leaded fuel;
 - c.** Damage due to an accident, negligence or misuse;
 - d.** Converters installed on vehicles with modified exhaust or emission systems.

CALIFORNIA SAFETY STATEMENT: The catalytic converters manufactured by AirTek will not in their operation, function, or malfunction result in any unsafe conditions endangering the motor vehicle, its occupants, or persons or property in close proximity to the vehicle.

ALL IMPLIED WARRANTIES INCLUDING THE WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO THE DURATION OF THIS LIMITED WARRANTY. AIRTEK, INC. SHALL NOT BE LIABLE FOR DAMAGES OR INJURY TO PERSONS OR PROPERTY RESULTING FROM MISUSE OR IMPROPER INSTALLATION OF THE CATALYTIC CONVERTER.
